Pierre, South Dakota

The SDHSAA Board of Directors held a regular meeting on April 20, 2021. The meeting was held at the SDHSAA office with Board and Membership participation allowed via Zoom. The following members were present in person:

Craig Cassens Randy Soma Marty Weismantel Tom Culver Dr. Jerry Rasmussen

The following members participated electronically via ZOOM: Mark Murphy Barry Mann Michael Talley

Staff members present included Dr. Dan Swartos, Ms. Jo Auch, Dr. John Krogstrand, Mr. Ryan Mikkelsen, and Mr. Aaron Magnuson.

The meeting was called to order by Chairman Craig Cassens at 12:04 P.M.

#### Item #1-Approval of the Agenda

It was moved by Marty Weismantel, seconded by Randy Soma, to approve the agenda as amended, with Item #13E (request from Sturgis Brown High School) added.

Motion carried 8-0.

#### Item #2- Open Forum

Chairman Cassens explained the Open Forum procedure and asked for speakers. Mr. Terry Rotert of Huron addressed the board in opposition to the proposed changes to the State Track and Field Meet Schedule. Mr. Jared Vasquez of Rapid City Stevens addressed the board in opposition to Golf Proposal #2. Mr. Jordan Bauer of Rapid City Central addressed the Board in support of the proposed changes to the State Track and Field Meet Schedule.

#### Item #3-Consider Proposed Changes to the 2021 State Track and Field Meet

Dr. Swartos, Dr. Krogstrand, and Ms. Auch addressed the Board regarding the proposed changes to the 2021 State Track and Field Meet due to COVID-19 restrictions and precautions.

It was moved by Dr. Jerry Rasmussen, seconded by Randy Soma, to approve the recommendations as presented. Following discussion, Dr. Rasmussen and Mr. Soma rescinded their motion and second.

It was moved by Dr. Jerry Rasmussen, seconded by Randy Soma, to approve recommendation A (change to three sites for both dates, changes to the meet schedule) as presented. *Motion carried 5-3, with Mann, Rasmussen, Talley, Weismantel and Soma voting AYE and Culver, Murphy, and Cassens voting NAY.* 

It was moved by Tom Culver, seconded by Marty Weismantel, to approved recommendations B,C, and D (changes in host management fees, approving amended contract with Dakota Timing, approving changes to officials fees). *Motion carried 8-0*.

Item #4- Conduct a first reading on proposed changes to the SDHSAA Athletics Handbook, proposed changes from the Sports Officials Advisory Council, and the Sports Medicine Advisory Council, as submitted by the various Advisory Committees/Councils. Explanations and rationales for all proposals can be found in the April 20 Board of Directors Agenda on the SDHSAA website.

Basketball- No proposals were submitted.

## Competitive Cheer

Motion by Randy Soma, second by Marty Weismantel, to approve the following Competitive Cheer Proposals:

- Cheer Proposal #2- Co-Ed Division revision
- Cheer Proposal #3- Cheer Rubric Clarifications

## Motion carried 8-0.

(Competitive Cheer Proposal #1 was sent back to advisory for more study)

## Competitive Dance

Motion by Tom Culver, second by Dr. Jerry Rasmussen, to approve the following Competitive Dance Proposals:

- Competitive Dance Proposal #1- Eliminate Kick as a Category
- Competitive Dance Proposal #2- Limit the number of Dance routines to any two styles of routines for all competitions.
- Competitive Dance Proposal #3- Change the Tie-Breaking procedure to highest score in a routine, least amount of safety deductions, and if the tie remains, award co-champions.
- Competitive Dance Proposal #4- Rubric and Scoresheet modifications

## Motion carried 8-0.

## Competitive Cheer and Dance

It was moved by Marty Weismantel, second by Randy Soma, to approve the following proposals:

- Competitive Cheer and Dance Proposal #1- Follow the NFHS the rule on hair.
- Competitive Cheer and Dance Proposal #2- Change the number of judges to 3 performance and 2 safety judges.

#### <u>Football</u>

It was moved by Dr. Jerry Rasmussen, second by Tom Culver, to approve the following football proposal:

• Football Proposal #1- Begin 9-man playoffs as a 16-team seeded bracket in the first round, with no re-seeding in any round.

## Motion Carried 8-0.

## <u>Golf</u>

It was moved by Randy Soma, second by Marty Weismantel, to approve the following Golf proposals:

- Golf Proposal #1- Change Class "A" regional qualifying standard from 60% to 50%.
- Golf Proposal #2- In Class AA beginning in 2021-22, a golfer must average an 18-hole score less than or equal to the current 75<sup>th</sup> percentile of all golfers at the previous six State Championship meets. Scores applied to this average are from any meet where more golf teams are present and will be tracked by the SDHSAA.
- Golf Proposal #3: Allow tee-to-green coaching in Class "A" and "B" in postseason rounds.

## Motion carried 8-0.

(Golf Proposal #2A was sent back to advisory for more study)

#### **Gymnastics**

It was moved by Marty Weismantel, second by Randy Soma, to approve the following Gymnastics proposals:

- Gymnastics Proposal #1- Adjust Class A Bars Individual Qualifying score from 8.3 to 8.0 and Class AA Bars Individual Qualifying Score from 8.8 to 8.7 for the 2021-22 school year.
- Gymnastics Proposal #2- Changes to the State Meet format. Eight teams would qualify (top team from each Region, next six highest overall team scores), separate A and AA session each day, Team day Friday, Individual day Saturday, A and AA rotate morning/afternoon sessions annually.

## Motion carried 8-0.

Soccer- No proposals were submitted.

## <u>Tennis</u>

It was moved by Mark Murphy, second by Marty Weismantel, to approve the following Tennis proposals:

- Tennis Proposal #1- For the State Tournament, continue to play Class A on M-T and Class AA on Th-F of NFHS Week 14, rotating between Sioux Falls and Rapid City annually.
- Tennis Proposal #2- Allow for a substitution for a singles player after competition has begun in the case of injury or illness.
- Tennis Proposal #3- Allow 10 game prosets with a 7-point tie break when players reach 9 all to determine the winner of the contest.

## Motion carried 8-0.

(Tennis Proposal #4 was sent back to advisory for further study)

Track and Field/Cross Country- No proposals were submitted.

## Volleyball

Motion by Tom Culver, second by Marty Weismantel, to approve the following proposal:

• Volleyball Proposal #1- Allow Class AA volleyball teams to play up to 3 matches versus Class A or Class B opponents, or in an out of state tournament, without a deduction of seed points.

## Motion carried 7-1, with Soma voting NAY.

# Wrestling

It was moved by Randy Soma, second by Dr. Jerry Rasmussen, to approve the following Wrestling proposals:

- Wrestling Proposal #1- Adopt weight classes for a single classification of Girls Wrestling, beginning in 2021-22, of 106, 113, 120, 126, 132, 142, 154, 170, 190, & 285.
- Wrestling Proposal #2- Award a Girls Team Championship based on the adopted weight classes in proposal #1. One entry allowed per team, 16 person brackets for brackets with 9 or more participants, 8 person brackets for brackets with 6,7, or 8 participants, and Round Robin for brackets with 5 or fewer entries. One-half of the bracket size will be seeded. If more than 16 are entered into any weight class, TrackWrestling/SDHSAA criteria will be used.
- Wrestling Proposal #3- Amend the State Wrestling Tournament schedule as follows:
  - Thursday Session 1- First Round Matches
  - Thursday Session 2- 1<sup>st</sup> Round Conso/Quarterfinals, followed by 2<sup>nd</sup> Round Conso
  - Friday Session 1- 3<sup>rd</sup> Round Conso/Semifinals, followed by 4<sup>th</sup> Round Conso
  - Friday Session 2- Placing Matches, followed by Championships
  - Saturday- All Dual Competition
- #4- Wrestle State Duals out to six places.

## In/Out of Season & AD Advisory Committee- No proposals were submitted.

#### Sports Officials Advisory Committee

It was moved by Marty Weismantel, seconded by Tom Culver, to approve the following proposals:

- Proposal #1- Change number of Dance Judges at the state meet to 3 performance and 2 safety.
- Proposal #2- Change the number of Gymnastics judges at the state meet from 16 to 9-13.

#### Motion carried 8-0.

Item #5- Conduct a First Reading Related to Alternate State Event Sites for 2022-23 and 2023-24 Class A and AA Girls Basketball, a Changed Site for 2024 State Gymnastics, and all State Events for the 2024-25 School Year

It was moved by Randy Soma, seconded by Barry Mann, to approve the recommendations as presented on a first reading. **Proposal located in Appendix A of the minutes.**
