The SDHSAA Board of Directors held a regular meeting on April 12-13, 2023. The meeting was held on April 12th, 2023 at the SDHSAA office with Board and Membership participation allowed via Zoom and completed in person and via Zoom on April 13th, 2023. The following members were present in person:

The meeting was called to order by Chairman Mark Murphy at 12:42 P.M.

Item #1-Approval of the Agenda

It was moved by Marty Weismantel, second by Dr. Jeff Daniesen, to approve the agenda as amended, with the addition of item #4.5- Softball tournament rules.

Track and Field/Cross Country-

It was moved by Dr. Jeff Danielsen, second by Eric Denning, to approve the following Track and Field/Cross Country proposals as a first reading:

- T/F Proposal #1- Only FAT allowed for Top 24 qualifying beginning 2023-24.
- T/F Proposal #2- Add Javelin to Class A and B for 2023-24
- T/F Proposal #3- Remove region meets for Class A and B
- T/F Proposal #4- Add 1 point team deduction for coaches misconduct and immediate removal from the event.

Motion carried 9-0

<u>Volleyball</u>

None of the proposed volleyball changes reached a 60% threshold on the AD vote, there was no action to approve any proposed changes.

<u>Wrestling</u>

It was moved by Tom Culver, second by Marty Weismantel, to approve the following Wrestling proposals as a first reading:

- Wrestling Proposal #1- Utilize the NFHS 14 weight class model for boys wrestling and NFHS 12 weight class model for girls wrestling beginning in 2023-24.
- Wrestling Proposal #2- Deviate from the NFHS 12 weight class model in girls wrestling and set the upper limit for heavyweight at 250 pounds for 2023-24.
- Wrestling Proposal #6- Establish alternate wrestlers for the girls state wrestling tournament

Motion carried 9-0.

It was moved by Kelly Messmer, second by Eric Denning, to approve the following Wrestling proposal as amended as a first reading:

• Wrestling Proposal #4- Establish Girls Wrestling Regional Qualifer model, effective the 2024-25 school year.

Motion carried 9-0

Wrestling Proposal #5- Dual team region qualifier for state team duals, was tabled until the June 2023 Board meeting.

In/Out of Season & AD Advisory Committee-

It was moved by Kelly Messmer, second by Marty Weismantel, to approve the following In/Out of Season/AD Advisory proposals as a first reading:

- In & Out/AD Proposal #1- Increase the dollar amount of fines by \$100 for violations of the In/ Out of season rules
- In & Out/AD Proposal #2- Change the 25% violation for athletes violating In/Out rules
- In & Out/AD Proposal #3- Change wording from 4th Monday to 30 Calendar days for team membership
- In & Out/AD Proposal #5- All-Star Changes: Allow for SDHSAA waiver and approval

Sports Officials Advisory Committee

- Sports Officials Proposal #3- Change volleyball officials jacket requirement to Smitty Collegiate Women's Basketball jacket for postseason contests.

Sports Medicine Advisory

It was moved by Eric Denning, second by Mike Talley, to approve the following proposal as a first reading:

- SMAC Proposal #1- Add a mental health representative to the SDHSAA SMAC
- SMAC Proposal #2- Exempt licensed healthcare providers from the SDHSAA coaches education requirement of taking the NFHS First Aid/CPR course biannually.

Motion carried 9-0.

Item #4a- Conduct a first reading related to Site Selection Committee Recommendations on sites for 2026-27, Class A Girls Basketball in 2026, Softball in 2024, and One-Act Play in 2025 and 2026

It was moved by Eric Denning, second by Dr. Jeff Danielsen, to approve the Site Selection Committee recommendations.

Motion carried 9-0.

Item #4b- Consider switching 2024 State Track and Field Meet from Rapid City to Sioux Falls

It was moved by Mike Talley, second by Tom Culver, to approve switching the 2024 State Track and Field Meet from Rapid City to Sioux Falls.

Motion carried 8-1, with Dr. Jeff Danielsen dissenting.

Item #4.5- Approve Softball Regulation Game Adjustments for Tournament Play

It was moved by Marty Weismantel, second by Tom Culver, to approve the option of allowing for five inning games or 90-minute game time limit during regular season tournament events with a minimum of four teams participating.
