

# LINEUP QUESTIONS

In the last newsletter, I had the situation with #55 attempting to enter the contest but was not on the roster. Just to be clear, the player would be allowed to play after the penalty is accessed. I refer to that as "Pay to Play" Penalty. This would be considered an illegal substitution once the player enters the substitution zone and is recognized by the official. Then the penalty is loss of rally/point and the player may be added to the roster as a "Pay to Play" penalty.

**Situation C:** Team A starts the match and as the match progresses, #55 enters the substitution zone to enter the set. The scorekeeper tells the R2 that #55 is not listed on the roster. What happens? **Ruling:** Rule 7-1-1 Penalties 3: When a player is not listed on the roster and attempts to enter the set, the substitution is illegal and is penalized with a loss of rally/point.



# **CENTER LINE CONSIDERATIONS**

Rule 9-5-7 states that a player may touch the floor across the centerline with one or both feet, or hands PROVIDED a part of the foot/feet or hand(s) remains on or above the centerline. Contacting the floor across the centerline with any other part of the body is ILLEGAL. Therefore, feet/hands (as long as part of their feet or hand remain on or above centerline) are legal. Knee, shoulder, arm, head, (not hair) touching the floor PARTIALLY ACROSS the centerline would be considered a violation.

- 9.5.7 Situation: The LF on Team S and the RF on Team R are engaged in a play at the net. The LF on Team S lands with her foot partially across the centerline. The RF on Team R then lands with foot partially across the center line yet on top of the Team S player's foot. The player on Team S falls, stumbles, and is unable to make a play on the ball falling near her.
- Ruling: Center line violation on Team R. Both players may touch the floor across the center line with one or both feet/hands provided a part of the feet or hands remain on or above the center line and provided neither player interferes with the opponent's attempt to play the ball.

# PROPER FOOTWEAR ON THE COURT

Reminder, that the only people that are given graces to the footwear are adult personnel/coaches. Any players, managers, etc. out on the court need to be properly attired in appropriate footwear (tennis shoes). Adults are the only ones given the liberty to wear such things as sandals, dress shoes, high heels (which I am certain you wear all the time, just like I do. :) However, any other personnel on the floor needs to be in tennis shoes and those players should be limited to the number of players.

# JACKET PROTOCOL

I have been asked to put something in the newsletter about jackets and when is the appropriate time to take them off to officiate the contest? I do not have anything locked in on this topic, but if you were to ask me how I would suggest officials handle this, it would be something like this:

I would suggest that officials take their jackets off at about the 2:30 minute mark and keep them at the table before going across the court to be introduced. This will still give the R2 time to check the lineup with the score keeper at the 2:00 minute mark to make sure everything is ready to go for the match. When the horn sounds, officials and line judges will go across the court for introductions and the match will begin. This is a suggestion, not a mandate in any means!

### POST SEASON PLAY

Post-season play will begin in less than two weeks. Are you ready? Every match is a the biggest match you will work.

Come prepared, review rules and casebook situations. Do not get caught off guard. Expect the unexpected and be over prepared rather than under prepared. Be professional at all times.

Officials may also use pink whistles for the matches in October as well. Otherwise, the uniform should stay the same for these matches.
