# South Dakota Cross Country/Track & Field Officials Association (SDCCTFOA) Fall, 2023 Newsletter



# **SDCCTFOA**

A small group of interested track & field/cross country officials met with SDHSAA officials in June 2023 to promote the idea of an association dedicated to the sports of track & field and cross country. The meeting gave rise to the creation of a statewide association.

Officers were selected, and an initial membership meeting was held on Tuesday, August 22, 2023 via Zoom. The minutes of that meeting are below:

President Tim Casper called the inaugural meeting of the SDCCTFOA to order at 7:00 pm CDT. President Casper noted that the meeting was being recorded, and it would be archived and posted on the SDHSAA Web Site.

President Casper called the roll for board members: President-Elect J.D. Evans; Secretary/Treasurer Dana Nelson; Regional Coordinators Randy Thomas, Steve Charron and Larry Stevens. All were present. Additionally, 43 members (registered officials) were present via Zoom, facilitated by Randy Soma, SDHSAA.

The members recited the pledge of allegiance.

Bo Beck moved and Marc Murren seconded the approval of the agenda as distributed to the membership. Motion was approved.

President Casper opened the meeting to public comment, however there were no public comments from the membership.

Being no previous meeting, there were no minutes to approve.

Secretary Treasurer Dana Nelson reported that a checking account will be opened at the First Dakota National Bank (locations in Sioux Falls, Pierre, Yankton, Mitchell, Vermillion, Beresford, Chamberlain, Elk Point, Kimball, Parkston, Salem and Wagner) upon receipt of the initial membership fees from the SDHSAA. Based on the \$5.00 per official fee (84 officials) collected by the SDHSAA, an initial balance of \$420.00, will be deposited in the account. There being no bills to approve, Nelson did advise that there may be a modest cost for checks. It was noted that in addition to Nelson, President Casper, President-Elect Evans and Jo Auch from the SDHSAA would be signatories on the account.

Tom Parquet moved and Kevin Nelson seconded approval of the financial report. Motion was approved.

President Casper reviewed the Constitution for the membership, noting that the officers included a President, President-Elect and a Secretary/Treasurer, all elected for three year terms. With this structure, the President-Elect moves into the President position at the end of the current term. Nominations and elections would occur for President-Elect and Secretary/Treasurer for a three year term at that time.

President Casper continued discussing the Constitution, and noted that it would be advisable to select replacements for himself and Secretary/Treasurer as Regional Coordinators for Regions 1 & 2. Discussion centered on expanding the involvement of more officials, thus assuring viability for the organization going forward. It was decided to accept nominations for the two positions, and further to identify what the responsibilities for regional coordinators. The SDHSAA will facilitate nominations and voting for the regional coordinator positions, and the current board will establish a list of responsibilities for the positions.

President Casper continued his discussion of the Constitution, and at the conclusion of his discussion, Marc Murran moved and Larry Stevens seconded the approval of the Constitution for the SDCCTFOA. Motion was approved.

There being no Old Business, the meeting proceeded to New Business.

Under New Business, President Casper, with assistance from Randy Soma with SDHSAA, reviewed the website for Cross Country, covering links for the Constitution, Agendas, Minutes, Newsletters, and what will become a link for interpretations and other information (Casper's Clarifications). President Casper also noted and covered the items in the Cross Country Guide.

President Casper noted that the web site may be capable of being used as a clearinghouse for officiating schedules and other items such as procuring shells. Secretary/Treasurer Nelson reported that his contact with the Iowa Association of Track Officials Secretary/Treasurer Bill Neal revealed that Winchester is unlikely to manufacture blanks in the future. In previous years Iowa had procured shells that it subsequently sold to its members—last year at the rate of \$40/box for 32 caliber. Nelson further noted that he had purchased a 9mm starter pistol, for which shells are available for about \$25/box. A 9mm is about the same as a 38 caliber.

Randy Soma, using the technology of Zoom, went to web page and opened the various links to show the membership how they might use the web site to find information, keep up on developments of the association, and view various items in the links.

There being no Reports at this time, President Casper indicated the next meeting would be at the call of the President. Larry Stevens moved that the meeting by Adjourned. The meeting was adjourned at 7:38 pm CDT.

This is the first of several newsletters of the newly created South Dakota Cross Country/Track and Field Officials Association. The purpose of the SDCCTFOA is as follows: a. To promote the sport of cross country/track & field. b. To unite all high school cross country/track & field officials. c. To promote consistency in the interpretation of the rules according to the NFHS rule book. d. To maintain a high standard of cross country/track & field officiating. #### As Regional Representatives, these individuals are expected to:

Regional Representatives shall be appointed by the Board of Directors for a three- year term, consistent with the provisions of the SDCCTFOA Constitution.

Regional Representatives are members of the Board of Directors for the SDCCTFOA.

A SDCCTFOA Regional Representative is responsible for all the territory and officials listed within their regional boundaries and identified in the SDCCTFOA Constitution. Regional Reps will interact with and communicate with the officials in their region and are responsible for their inquiries and requests.

Regional Reps are responsible for conducting one in person meeting in their region for the purpose of conducting an in-person clinic. Topics for the clinic will be identified by the Board of Directors of the SDCCTFOA and a lesson plan will be developed by the board. The clinic will be conducted by either a designated clinician or by the Regional Rep, as appropriate.

Regional Reps may be tasked with additional duties or responsibilities by the Board of Directors as needed.

# **Casper's Clarifications**

#### For Meet Referee, Starter, Assistant Starter, Head Field Judge

5 to 8 schools (approx. 4 to 6 hours)	\$250	\$225
9 to 16 schools or more (approx. 6+ hours)	\$300	\$250

#### **For Shells**

Shells (32 caliber for outdoor/22 caliber for indoor) must either be provided by the school or purchased from the starter at a rate acceptable to the starter, generally shells at retail:

32 caliber box (50 shells) Winchester blanks: \$60.00 to \$80.00/box 22 caliber box (50 shells) Winchester blanks: \$30.00 to \$45.00/box

#### For Mileage

State rate for driver, with rider mileage to second & third official. If officials travel from different directions or cannot coordinate, each official should receive mileage.

#### **Contingencies**

If meets add additional schools after an initial contract is agreed to, because of inclement weather, the cancelling of meets, or schools from outside the area attending because facilities in their area are not available, Athletic Directors should make adjustments to the contracted fee consistent with the guidance above. Officials anticipating a 4-5 hour meet, suddenly are booked for 6-10 hours need to be compensated accordingly.

Additional knowledgeable officials or individuals can do much to enhance the athletic experience for these high school athletes.

### **Iowa Association of Track Officials Starter's Clinic**

This "hands on starters clinic" sponsored by the Iowa Association of Track Officials is for new and experienced starters who want to take an opportunity to improve their skill and knowledge of starting track races. A major purpose of the clinic is to provide each starter a "hands on" segment to do live starts.

Ammo will be provided and high school athletes will be available for demonstration.

Each starter attending the clinic will need to bring their own .22 starting gun/ear protection.

Another purpose of the starter's clinic is to explain the new National Federation of High School false start rules for track and field in 2024 and how to call these new starting violations.

Starters will receive instruction in:

- \* starting commands
- \* starting mechanics
- \* starting violations
- \* hurdle rules
- \* exchange zone violations
- \* basic track umpiring

Instruction will be provided by the following:

- \*Terry Thompson- NCAA starter, Drake Relays starter, Iowa High School State meet track referee, Iowa High School State cross country starter/referee
- \*Mike Stanley- Iowa High School State track/cross country starter, NCAA starter, Iowa High School State cross country referee
- \*Bill Neal- Iowa High School State track/cross country starter, NCAA starter, Iowa High School State cross country referee, Drake Relays High School track referee
- \*Jim Nichols Iowa High School State meet referee, NCAA meet referee

Clinic will be capped off at 20 starters per session at each site. This will allow each starter more opportunities to start races. Get signed up today to reserve a spot at the clinic.

# **32 Caliber Starting Shells**

The Iowa Association of Track Officials (IATO) recently advised its membership that the Winchester company has no plans to make .32 Winchester blanks for the 2024 track

season. They were advised Winchester was having trouble getting all the components for making blanks. Plus, Winchester makes more money selling live ammo, since there isn't a large market for starter blanks.

Winchester will be communicating with its ammo vendors on their plans for the 2025 season later this fall.

The National Federation is aware of this situation, with the hope they may have some answers.

The Iowa association has been contacting vendors and searching to find replacement shells. In previous years IATO has made bulk purchases of shells for officials, but has determined they will not be able to do so for the 2024 season. While this is something that has been discussed for the SDCCTFOA to do in the future, we will likely wait to see how Iowa comes out on their efforts.

So, be aware, schools may not be able to secure shells for next spring. Check the number of track meets you have against your inventory of .32 blanks. If you're short get on the internet to look for an alternative. Soon starters from other states will be looking for .32 blanks.

One alternative may be to buy a 9mm starter pistol. Currently 9mm pistols are available, and shells are about \$25 for a box of 50. Several area officials have already acquired a 9mm gun.
