Jan was a coach from 1974-79, she continues to be the Wisconsin Rules Interpreter and Clinician. Jan received the NFHS Outstanding Service Award in 2011, she has served as a NFHS Committee Member and has been the NFHS Gymnastic Committee Chair since 2012.

Jan's love and passion for gymnastics is still thriving. The world of gymnastics has provided many rewarding and proud moments. A chance to experience gymnastics around the country, share in and witness gymnasts, coaches and other judge's mutual love of the sport, and develop life-long friendships has been a privilege and a joy throughout the years.

Prior to that she was Chair of the NFHS rules committee from 2006-2012 and was a committee member and Chair from 1983-1993. Kathy continues to serve the Illinois High School Association as Chair of the Boys and Girls Advisory Committee and Head Clinician for Girls Gymnastics. Kathy received the National Distinguished Service Award from the National Federation of Interscholastic Officials Association and also from the Illinois High School Association. She was also named the Illinois Official of the Year and was inducted into the Illinois High School Girls Gymnastics Coaches Hall of Fame.

Kathy is a retired high school athletic administrator, teacher of physical education, driver education and coach.
